#### **CFEC School Partner Program is in full swing!**

Our CFEC Liaisons have hit the ground running, connecting with 17 SC public schools who are taking part in a statewide program to strengthen their family and stakeholder engagement efforts as a key strategy, to support continued recovery from the impacts of the pandemic on areas such as student academics, attendance, and behavioral and mental health.

The School Partner Program of the Carolina Family Engagement Center (CFEC) is a federally funded initiative to aid primarily Title I schools in leveraging school, community, and family resources in support of meaningful school-home relations and increased student achievement.

To participate in the program, state public schools with a poverty index of 60% or higher submitted applications — with approval from their school districts — agreeing to commit to a two-year period of high-quality training and technical assistance in family engagement provided by CFEC at no cost to the schools or districts.

The CFEC School Partner Program is composed of three (3) primary initiatives: a Schoolwide Stakeholder Partner program; a Teacher Partner program; and a Parent Leadership Partner program. These program "pillars" support family engagement capacity-building for both educators and parents. Specific strategies in each pillar will be selected in collaboration with participating schools to align with their academic and school climate goals.

The Parent Leadership Partner component works to strengthen parents' ability to engage in their children's learning and development in partnership with the school and to grow a supportive network of parents. This effort brings together groups of up to 15 parents for seven sessions built around CFEC's Parent Leadership Partner workbook. Parents also work individually or in groups to create and implement a small project intended to address an education-related need in their school or community.

CFEC is the Statewide Family Engagement Center for South Carolina. It is housed in the SC School Improvement Council at the College of Education at the University of South Carolina. Anticipated outcomes from participation in CFEC's School Partner Program include an increase in the number of effective family-school partnerships that support parents as active participants in their children's learning and development, and improved school climate. Educators will have increased satisfaction with home-school relationships and a greater ability to use family engagement as a strategy for classroom and school improvement.

For families, envisioned outcomes include their increased satisfaction with homeschool relations, stronger engagement in their children's learning and development, increased capacity to engage in effective partnerships with their children's schools, and greater participation in school decision and/or policy making.

# Partnering for Progress - CFEC Eliminates Barriers to Family and Community Engagement

In October 2023, the U.S. Department of Education renewed the Carolina Family Engagement Center's grant to serve as South Carolina's Statewide Family Engagement Center (SFEC) under the Every Student Succeeds Act (ESSA). As we look back on our previous grant, Marketing and Communications Coordinator, Aïda Rogers, sat down with our staff, Liaisons, and partners to look at the incredible work that has been done across South Carolina in the last five years.

From tutoring and mentorship programs, and community partnerships with museums and school gardening programs, family engagement means better schools for all students.

### A New Resource from CFEC to Support Districts in Engaging Multilingual Families!

Several years ago, CFEC initiated a conversation with multilingual learner (MLL) families and community organizations supporting MLL families to better understand how we could encourage increased levels of engagement with their children's schools. It became clear that access to interpreters and translators was an essential foundational component of all partnerships between MLL families and schools, and that this was an area where schools and parents needed additional support.

CFEC's new guide for public school districts (districts) on language access is an outgrowth of these conversations. Developed in partnership with Spanglish Consulting in Charleston, SC, this resource guide is intended to (1) increase awareness of federal laws requiring districts and schools to communicate with MLL parents in a language that they understand and (2) share tools and resources that can assist South Carolina districts in meeting their obligations to MLL parents generally and Spanish-speaking parents in particular.

We hope that this guide will help districts navigate the challenges they may face in complying with federal language access requirements. We also hope that it will inspire community agencies and organizations at the state, regional, and local levels to explore new ways to collaborate and support South Carolina school districts in meeting these requirements. Working together, in South Carolina, we can meet the challenges of language access and move our state closer to the shared goal of engaging all families in the learning and development of their children!

# **Congratulations to Laurann Gallitto Patel -** SC Education Policy Fellow!

Congratulations to CFEC Liaison & Project Lead for the Midlands, Laurann Gallitto Patel, on her completion of the South Carolina Education Policy Fellowship Program (SC-EPFP)! The SC-EPFP is a 10-month professional development program for established and emerging leaders in education and related fields, designed to work toward the implementation of sound education policy and practice in South Carolina.

Laurann's cohort advocacy project was centered on addressing the SC teacher shortage by enabling DACA (Deferred Action for Childhood Arrivals), often referred to as Dreamers, interested in the teaching profession to receive in-state tuition and state scholarships/grants and be eligible for professional licensure in the teaching profession.

Laurann remarks, "During my time in the Program, we also made group visits to the SC Statehouse, various schools such as South Carolina Governor's School for the Arts and Humanities and South Carolina School For the Deaf and the Blind, and met monthly to receive professional development and hear from professionals in the field of education. I



truly enjoyed my experience meeting and learning from so many dedicated, passionate peers from across South Carolina and appreciate all the diligent planning of the facilitators, Tom Hudson and Bruce Moseley."


